- ~~➤ Critical - Variable interpolation: `{{ site.data.keyword }}` not being replaced
Complete, issue 40 branch, [issue 21](#)~~
- Critical - perform all reviews before publishing
Content review, Functional review (links, markup validation), Technical Review (is it correct, complete)
- Ongoing - maintain list of missing items to address at a later point, should open as GitHub issues
[Issue 53](#): Enhance HTML page with MD template
[Issue 54](#): Enhance Swagger JSON files with JS template
TBD: Identify pages with images that will need to be updated - *where to store list of all site pages?*
- Not MVP - Plan for images (SVGs)
Investigate markup-based image generation, w/support for variable interpolation
- Not MVP - process to crawl files, seed list. Confirm no orphan pages, no bad links, valid markup
